FRED WEHRLI MEMORIAL TOURNAMENT RULES 2018

1) Dates & Fees: Team competition, club members only, non member relatives allowed as a partner; 1 or 2 paid participants per boat. Event takes place on Pomme de Terre Lake
Tournament Date & Fishing Hours: April 21ST, 9 am to 3 pm.
No make-up date in the event of bad weather.
Entry fee is \$50 per team.

Lunch at State Park Marina included with paid entry fee.
Big fish 100% payback is \$10 per team collected and paid on event day.

All fees must be paid prior to fishing. The Tournament Committee may cancel or delay the start of the Tournament due to safety issues or inclement weather.

2) All Missouri Conservation Water Safety Regulations will be in force, live bait prohibited. Trolling is limited to three rods per entrant with one lure limit on each rod.

The Alabama, umbrella and similar rigs may be fished so long as they use only **ONE** lure. The remaining attachment points can include similar lures so long as their hooks have been removed or other hook-less attractor such as spinner blades are used.

3) Tournament check-in takes place at STATE PARK MARINA. Check-in is 30 minutes prior to the start of the tournament.

4) All caught muskies are scored & must be released immediately. No witness required from outside the boat. One digital photo showing length required.

5) Scoring; Muskies will be scored as follows: **4 Points for each muskie 30" or longer; 2 points for each muskie less than 30"** plus 1/4 point for each additional 1/4 inch, measure to the nearest 1/4 inch. Accumulation of most points wins the tournament.

6) Prizes: 1st place team only; Cash that equals 50% of tournament entry fees less meal allowance & two custom T shirts.

6a) In case of a tie, winner will be determined by earliest release time on Release Forms for the tournament. No kept muskie will be allowed for tournament entry.

7) No alcoholic beverages are allowed during tournament hours.

8) The Tournament Committee is the final judge of all tournament rules and decisions. Life jackets are to be worn at any time that a boat is underway, except that the jacket need not be worn while trolling. Not wearing life jackets while underway will be grounds for disqualification from any prizes and be subject to expulsion from the Tournament.

9) The participants agree to allow the Pomme De Terre Chapter of Muskies Inc. to use photos obtained during the tournament & awards for publicity purposes.

OPTIONAL BIG FISH POT There will be a daily big fish pot with 100% payback. Entry will be \$5 per individual collected & paid on tournament day. The pot will be for the longest muskie. Digital photo required. If there is no winner, the money will be drawn from among those entered in the pot. Only those individuals that have entered the Big Fish Pot will be eligible for winning the pot. Longest muskie wins. In case of a tie, winner will be determined by earliest release time on release card.

- 3) I will comply with all the rules and regulations. If I have any question, or observe any unusual or unnecessary hazard during my participation, I will immediately bring such to the attention of the nearest official; and
